The purpose of this procurement is to establish a contract with a provider for Temporary Staffing Services to create temporary disaster-relief employment that addresses the impacts of the opioid crisis in affected communities. The contracted staffing agency will process participant payments and assist the program-operator universities in placing participants in field placements at pain management clinics, local non-profit organizations, local governmental organizations, and other entities directly involved in addressing the opioid crisis, as identified in cooperation with the program-operator universities.

The program aims to address the opioid crisis by increasing the number of professionals in the areas of public health, mental health, pain management, clinical mental health, rehabilitation counseling, and addictive treatment and other related fields in the communities most affected by opioid. The Contractor will place post-secondary educational students and professionals meeting the qualifications for dislocated workers, unemployed, underemployed, self-employed, and displaced homemakers in fieldwork locations for training in occupations impacted by the opioid crisis.

The term of the Temporary Services Contract will be from July 1, 2023, and end on June 30, 2026. The agency reserves the right to renew the contract for up to two (2) additional years at the sole discretion of the Agency. The anticipated budget for this contract is \$4,000,000.00.

Based on the evaluation of the submitted bids, MDES announces the intent to award a contract to the lowest, responsive, and responsible bidder whose bid meets the requirements set forth in MDES IFB 2023-01 pending approval by the Public Procurement Review Board. These requirements included minimum prior experience, proof of registration to conduct business in the State of Mississippi or acknowledgement of intent to register, evidence of financial stability or solvency, methodology for fulfilling contractual obligations, and a minimum score from submitted references. The vendor below met all requirements and was the lowest cost.
