Employee Mass Layoff Guide

1st Time Employee: Create ID and Password

The MS Unemployment Program requires that individuals seeking unemployment payments must file a weekly certification. In order to complete the weekly certification, a User ID and Password is required.

Employees who have not previously logged into the ReEmployMS Unemployment system will need to create their User ID and Password. To begin the process, go to the MDES website <u>www.mdes.ms.gov</u>. From the website please follow the below instructions.

1. Select Individuals: Unemployment Insurance Services>



2. The ReEmployMS login screen for unemployment insurance will be displayed. Select the *Login* link.



3. Enter all information and Select Next

Employee Weekly Certification Process

The Unemployment Program requires that individuals seeking unemployment payments must file a weekly certification. Weekly certifications are required for each week that you are not working or the weekly hours are reduced due to the business shutdown or partial shutdown. Weekly certifications are filed on the Sunday or Monday after each week you are not working or that you worked reduced hours.

Example: Business is shutdown from Sunday, March 21, 2021 through Saturday, March 27, 2021. You would file your weekly certification on Sunday, March 28 or Monday, March 29.
